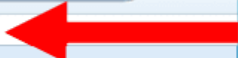

#### Employer compliance – Fees

**Notes:**

**Employer Compliance maximum fee:** To be eligible for the employer compliance maximum fee, the employer must make offers of employment to a group of three or more foreign nationals, consisting of performing artists and their staff, at the same time.

**Note:** New fees to be paid by employers and open work permit applicants are being introduced on February 21, 2015. There is also a new process that employers must follow when hiring Labour Market Impact Assessment-exempt foreign workers.

To pay your fees online you will need:

- a Visa®, MasterCard® or American Express® credit card or
- a debit card issued from a Canadian Financial Institution such as BMO, TD, Scotia Bank or RBC.

**Note:** The debit card must be enabled for the **Online Interact Program only**. If combined with another debit program, it will not work as a debit card (i.e. Visa Debit or MasterCard Debit).

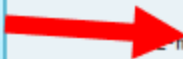
